This is calculated annually on the date your fixed-rate period started.</li> <li>You can make additional payments during the fixed-rate period without incurring an early repayment charge (ERC).</li> <li>Anything over the 10% will incur an ERC, which you may have to pay if you repay the whole or part of your mortgage early. This includes if you move to a different NBK mortgage rate, or move to a different lender during your fixed period.</li> <li>In the first year of your fixed rate period, the ERC is calculated as 2% of the amount repaid early, above any annual overpayment allowance. In the second year, the ERC is calculated as 1% of the amount repaid early, above any annual overpayment allowance.</li> </ul>

Self Employed	<ul style="list-style-type: none"> <li>KYC documents of borrower / guarantors</li> <li>Audited financial statement for the last three years.</li> <li>Personal bank statements for at least 6 months</li> <li>Net Worth statements.</li> <li>Proof of any other income</li> </ul> <p>[We may require additional documents for verification]</p>
