

Terms and Conditions of Mastercard

Campaign Terms and Conditions:

1. Campaign is valid from 22 February to 30 April, 2024.
2. Customer should register one time only for the campaign through NBK Website.
3. Customer should spend a minimum of KD 250 using any of the eligible NBK Mastercard Credit or Prepaid Cards, including:
 - UEFA Champions League World Mastercard Credit Card issued by NBK
 - NBK Miles Credit Card
 - NBK World Mastercard Credit Card
 - NBK Platinum Mastercard Credit Card
 - UEFA Champions League Platinum Mastercard Prepaid Card issued by NBK
 - NBK Multicurrency Prepaid Card
4. Each KD 1 spent gives the customer:
 - 1 chance to enter the draw when spent locally
 - 2 chances to enter the draw when spent internationally
 - 3 chances to enter the draw when spent using any of UEFA Champions League Mastercard Cards issued by NBK
